Since 1986, 29,000 volunteers have worked on 2,200 projects, leveraging \$8.8 million worth of in-kind value in Alexandria. With a focus on serving our low-income citizens and neighborhoods, we have provided extensive upgrades to homes, schools, community parks, and non-profit facilities.

With the help of everyday citizen volunteers, skilled tradespeople and the support of funding partners, we keep low-income residents in healthy housing. By partnering with local organizations and volunteers,
