From community parks and gardens, to schools and homeless shelters, we partner with organizations to renovate these critical community resources. Because of the projects we've completed, children now have safe areas to play, neighbors have gardens in which to grow their own food, and whole neighborhoods have been revitalized.

4b (Code:) (Expenses \$ 1,034,610. including grants of \$) (Revenue \$) Our cornerstone program, Safe and Healthy Homes, focuses on stabilizing 25 items that the National Center for Healthy Housing found to drastically improve living conditions for a home's residents, with a particular focus on low-income persons living in older and/or substandard housing who are disproportionately affected by home hazards. This program provides free housing improvements and ensures low-income individuals and families can remain stably housed and spend their limited income on health and food.
