This program provides free housing improvements and ensures low-income individuals and families can remain stably housed and spend their limited income on health and food.

 Our Community Strong program provides improvements to common spaces used by thousands of Alexandria residents. From community parks and gardens, to schools and homeless shelters, we partner with organizations to renovate these critical community resources.
